Peter Lustgarten has a longstanding and generous commitment to Nemours/Alfred I. duPont Hospital for Children. As an owner of Concordville Nissan and Subaru in Pennsylvania, he has repeatedly used his connections and business opportunities in many creative ways to benefit the Hospital.

In addition, Peter and his wife Alison are members of **The Nemours Society**. Parents of two young daughters, they value having world-class care available right in their community for themselves and for the employees of the dealership.

Beginning eight years ago, Peter and his brother and dealership co-owner Stuart Lustgarten began contributing a portion of their personal profits from holiday weekend car sales, donating \$100 - \$200 for each car sold during that time to the hospital. ## A Caring Resource for Kids

The opening of Nemours Children's Hospital in Orlando inspired Dan Deighan to help children in a number of unique ways. "I wanted to give more than just money," says Coach Deigs. "It is important to me to be a resource for kids and give them some sense of control and normalcy during a stressful time."

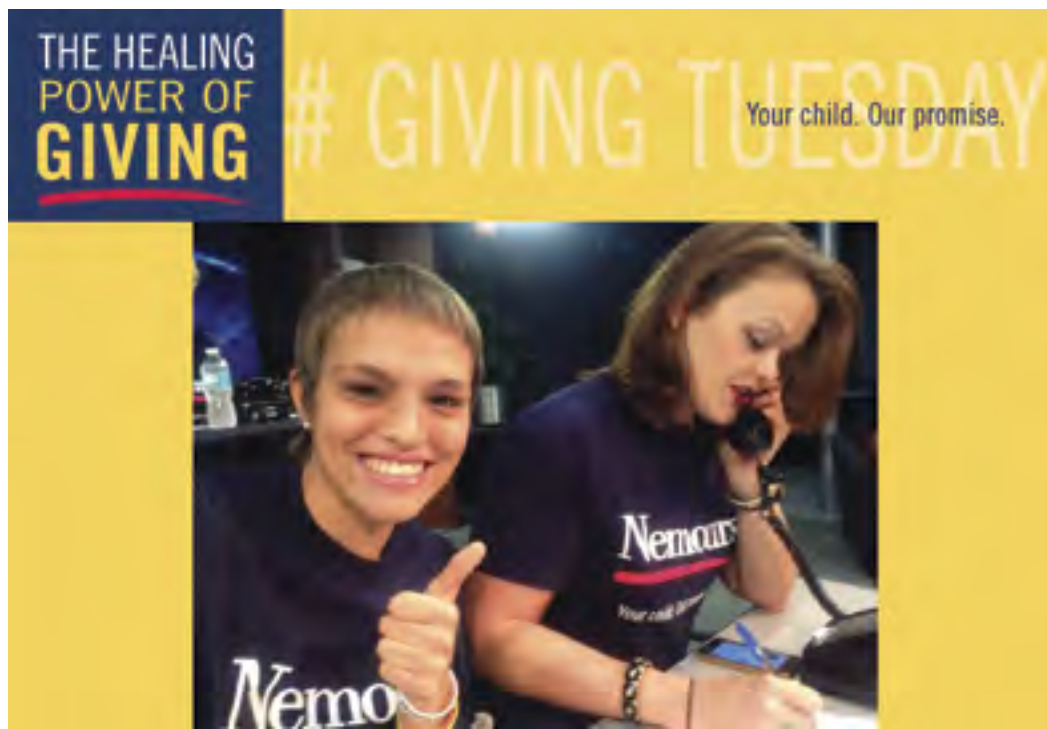

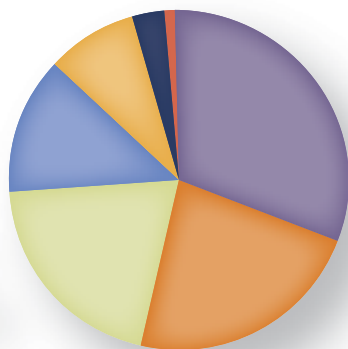

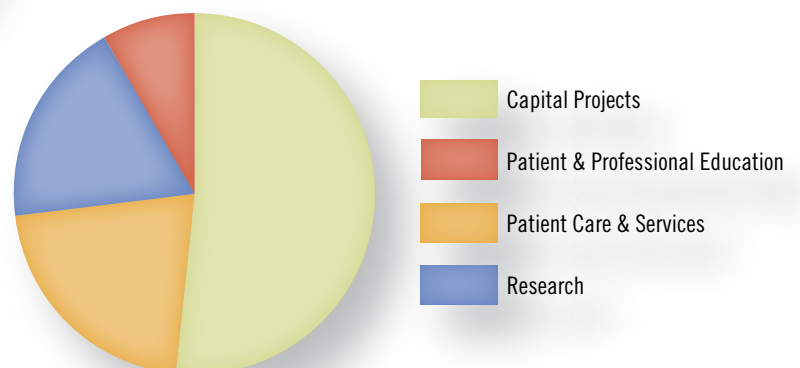

## Building A Healthier Future for Children

Excitement fills the air as Nemours/Alfred I. duPont Hospital for Children prepares to open its expansion building in October. Pictured above is the five-story atrium lobby, which will feature a Welcome Center, Einstein Bagels, an interactive Discovery Wall, Safety Store and The Red Balloon Gift Shop.

Designed with input from the Hospital's Family Advisory and Youth Advisory Councils, the expansion will have all private rooms with overnight accommodations for parents, spacious bathrooms and zones for patients, caregivers and families.

Through large, flat-screen televisions, our young patients will be able to access movies, games, The GetWellNetwork, the internet and videos prescribed by their nurses to help them understand tests, surgery or treatments. Kids may also order meals or snacks at any time of the day or night!

Families will enjoy many amenities, including spaces to be with their children outside the hospital room such as family solariums, Child Life playrooms, family lounges and "pocket parks." A washer and dryer will be available on each floor for the convenience of parents.

The expansion will feature specialized patient care units for general surgery, pediatric intensive care and orthopedics. The third-floor hematology/oncology wing will include a specially designed Blood and Bone Marrow Transplant Unit.

A new emergency department will have 44 beds, including a FastTrack unit for children with minor illnesses or injuries, a Clinical Decision unit for children who may or may not be admitted and two fully-equipped trauma bays. A rooftop helicopter pad will provide rapid access to the emergency department, operating rooms, and intensive care units.

The expansion will be surrounded by beautifully landscaped spaces, including a Healing Garden that offers a quiet place for reflection.
